#### Front Park Plans:

- Gary Huber attended to provide an update.
- In Front Park, last year we couldn't mow the grass because of thistle and plants blocking access.
- Gary helped remove plants last year and mulch the area around the picnic table.
- This year, we agreed to put down Preen on a limited basis (only the area around the table) to try to keep the thistle away for the season; he will only use the amount directed on the bottle to avoid any unnecessary impact to area
- Water spigot does not work need a long-term plan to resolve

#### Hidden Park Rejuvenation Project Update:

- Initial meeting at Angela's house was well attended
- Past President, Lee, indicated we are not currently a 501(c)3; need to investigate further
  - Action Item: Garrison is going to talk to Lee further
- Insurance and Liability: Where do we research? What restrictions do we need to be aware of? Current policy only insures non-residents. Fellow resident who is a lawyer has volunteered to help us review the policy to make sure that we are following what we need.
  - Action Item: Will connect with Casey Coyle to help review insurance policy.
- Survey for residents will be distributed at the Egg Hunt
- Basic needs: Even if we cannot launch a whole refresh this year, what can we do this
  year to help the park (i.e., thistle management, planting trees, and new picnic tables)

#### Various:

- Easter Egg Hunt is Saturday, March 23
  - Egg stuffing will be Wednesday, March 20
  - We will have the park mowed/weeded on Thursday, March 21
- Stephanie is willing to put signs out at Pavilion Park to remind about dues
- Garrison to get lock fixed
- Continuing to build list of shade trees that other municipalities approved between street and sidewalk; we will build off that to help petition Hampden Township
